The main reason for exit of EOUs is due to discontinuation of Income Tax benefits under Section 10B of Income Tax Act w.e.f. 1.4.2011.

(c) : There was an issue of reimbursement of Central Sales Tax (CST) paid by EOUs on purchases made from another EOU. The issue has been resolved by amending the Appendix 6H of FTP 2015-20 which now allows reimbursement of CST on purchases made by an EOU from another EOU.

(d) : A Review and Revamp Committee for EOU was set up under the chairmanship of Shri S. C. Panda, the then Development Commissioner, Noida SEZ in December 2010 to review and revamp the EOU Scheme with a mandate to suggest suitable steps to make the scheme more vibrant and attractive for investors, develop a synergy between EOU Scheme and SEZ Scheme and aligning the EOUs to make them more globally competitive. The Committee, in the July 2011, gave 32 recommendations to revamp the EOU Scheme which were examined and 8 recommendations were accepted by Department of Commerce in January 2014.

Details of the recommendations made by the Committee and recommendations accepted are furnished in Annexure.

(e) : No, Madam. The benefits provided to SEZ units, EOUs and DTA units cannot be compared. Therefore, the Government has not conducted any financial study or comparative study between Special Economic Zone, Export Oriented Units and Domestic Tariff Area Units.

Following recommendations have been accepted by the Department:

Validity of the period of Letter of Permission (LOP) issued to EOU: LoP issued to an EOU will have an initial validity for a period of 2 years to enable the Unit to construct the plant and install the machinery. The next extension of one year may be given by the DC for valid reasons to be recorded in writing. Subsequent extension of one year may be given by the UAC subject to condition that two-thirds of activities including construction, relating to the setting up of the Unit are complete and a Chartered Engineer's certificate to this effect is submitted by the Unit. Subsequent extension, if necessary, will be granted by the Board of Approval.

Aligning duration of goods and services in EOU with the term of LOP: At present, capital goods are required to be installed or otherwise used by the EOU, within a fixed period from the date of import or procurement thereof and other goods are to be used in connection with the production or packaging of goods within a period of three years. In case of failure to use within above stated period, extension is required. It has now been decided that the period of usage of goods should be coterminus with the period of LOP. This would do away with the current practice of obtaining multiple extensions for goods and LOP separately.

Setting up warehousing facilities outside EOU premises and outside the jurisdiction of DC: EOUs which intend to have their warehouses near to the port of export to reduce lead time for delivery of goods overseas and to address unpredictability of supply orders will now be permitted to set up such warehouses subject to the provisions related to export warehousing as given in notification No. 46/2001-Central Excise(N.T.) dated 26.6.2001 and the CBEC Circular No. 581/18/2001-CX dated 29.6.2001 as amended.

Sharing of facilities among EOU/STP/EHTP/SEZ Unit: In order to allow optimal utilization of infrastructure facilities it has been decided that sharing of facilities among EOUs may be considered by the UAC on case-to-case basis and the recommendations be sent to the BoA for final approval. While accepting such proposals, the NFE obligations of the Units shall not be altered. However, sharing of facilities between EOUs and SEZs Units should not be permitted.

Inter-Unit transfer (IUT) of goods & services : In order to facilitate a group of EoUs which sources inputs centrally to obtain bulk discount, reduce cost of transportation

and other logistics cost and to maintain effective supply chain, IUT of goods and services will be permitted on a case to case basis by the UAC.

Further, the procedure for Inter-Unit Transfer (IUT) of finished goods will be clarified by CBEC in order to bring uniformity in the practices and procedure adopted by various field offices.

Self-warehousing and self-certification of goods imported/procured by EOUs: The scheme of self-warehousing and self-certification was introduced vide Circular No. 19/2007- Cus. dated 3.5.2007 dispensing with the requirement for physical verification of imported/indigenously procured duty-free goods before issuing re-warehousing certificate by the proper officer in respect of Units set up under EOU/EHTP/STP/BTP scheme having physical export turnover of Rs.15 Crore and above in the preceding financial year and having a clean track record. In order to extend self-warehousing and self-certification facility to more Units, it has been decided to reduce the limit of physical turnover from Rs 15 Crore to Rs 10 Crore.

Rationalization of reports/ returns to be filed by EOUs: EOUs submit Quarterly Performance Report (QPR) and Annual Performance Report (APR) to the Development Commissioners and monthly return ER-2 to Central Excise. In order to reduce multiplicity of these reports, a common return to DoC and DoR would reduce paperwork for the EOUs. It has, therefore, been decided that a single common report/return may be devised which may serve the purpose for DoC as well as DoR. A joint group of DoC and DoR including Director General of Systems, CBEC will be formed to devise a proforma exhaustively capturing all the data and figures relating to export, import, DTA sale, deemed export sale, IUT, sale of goods as such, destruction, payment of duty etc. and devise simplified records to be maintained by EOUs.

Extension of time for submitting shipping bill for export made under self-sealing / self-certification: It has been decided to increase the mandatory requirement to submit Shipping Bill within 24 hrs to 48 hrs as it is sometimes difficult to reach jurisdictional Central Excise office within 24 hrs from the port of export.

(a) to (c) It is difficult to uniquely classify products into raw materials, semi-finished and finished, as the category of an item will depend upon the end use to which it is put, which can vary. There are around 11500 tariff lines (products) at 8 digit level in the Indian Trade Classification (Harmonized System) of Export and Import Items, 2012 [ITC(HS), 2012]. Goods/products including raw material, semi-finished and finished products are exported from the country as per the policy outlined in the said document.

There is a general fall in export of engineering commodities during the current year, which is also attributed to the overall global slowdown in trade during the year. Department of Commerce is interacting with industry to ascertain the corrective steps needed to sustain the long-time interest of India for export in this sector. Some of the recent steps taken to address the downturn in exports are:

- i. Revision of MEIS scheme under Foreign Trade Policy 2015-20 by inducting 110 new tariff lines and amplifying in MEIS support to 2228 existing tariff lines.
- ii. Introduction of Interest equalization scheme for 416 tariff lines.
- iii. Increase in duty drawback refund rates w.e.f. 23rd November, 2015

(a) & (b) Neelachal Ispat Nigam Limited (NINL) is a Joint Venture with the shareholders being Metals and Minerals Trading Corporation (MMTC) (49.78%), Government of Odisha through their two PSUs namely Industrial Promotion & Investment Corporation of Odisha Ltd. (IPICOL) (15.29%) and Odisha Mining Corporation (OMC) (12.32%), National Mineral Development Corporation (NMDC) (12.87%), MECON (0.86%), Bharat Heavy Electricals Limited (0.86%), Financial Institutions/Banks & Others (8.02%). Year-wise details of the performance of Neelachal Ispat Nigam Limited (NINL), since the start of its commercial operations in 2004 in terms of profit and losses and capacity utilization, are as follows:

Since commencement of commercial production in 2004-05 NINL has made profits for 7 years out of total eleven years of its commercial operation. The reasons for losses in recent years are mainly because of severe global recession since 2008-09 particularly in the steel sector leading to reduced demand for steel and allied products. Moreover, global increase in capacity and production has forced down global steel prices leading to more imports into India and low sales realizations for indigenously produced steel. In addition, the ban on mining of iron ore in some areas also led to steep increase in the prices of raw materials as well as inadequate supply of raw materials. The major reason for less capacity utilization is due to delay in commissioning of Steel Melting shop and irregular supply of raw materials.

(c) As per Agreement entered between Metals and Minerals Trading Corporation of India (MMTC) and NINL, MMTC has been earning a trade margin @ 3% from NINL towards facilitation of MMTC's diversified India wide marketing network as well as infrastructural / logistical support for sourcing of essential raw materials like iron ore fines, calibrated lumpy ore, manganese, dolomite, coking coal etc. and marketing of all the finished products and by-products of NINL in the domestic as well as international market. The details of trade margin earned from 2004 till 2014-15 by MMTC against the total investment and other financial support made so far are as below:-

- (a) The total quantity and value of fruits exported from the country during the last three years and the current year, country and item-wise, are at <u>Annexure I</u>.
- (b) Yes, Madam. The total production of Fruits during the year 2013-14 was about 889.77 lakh MT (Source: National Horticulture Board) against which the exports were only 4.39 lakh MT. Exports of agricultural commodities like fruits depend on various factors such as availability/non-availability of surplus over domestic requirements, international and domestic demand and supply situation, quality concerns, sanitary & phytosanitary requirements etc. In case of fruits, the reasons for low exports are high domestic consumption, fragmented supply chain, small land holdings, lack of appropriate infrastructure, high cost of logistics, difficulties in meeting global standards, high international transportation costs, etc.
- (c & d) Encouraging exports of agricultural products, including fruits, is a continuous process. The Agricultural and Processed Food Products Export Development Authority (APEDA), an autonomous organization under the administrative control of the Department of Commerce, provides financial assistance under various components of its 'Agriculture Export Promotion Plan Scheme' to the eligible exporters of fruits registered with it. Also, under the Foreign Trade Policy 2015-2020, exports of most of the fruits are eligible for up to 5% reward under the Merchandise Exports from India Scheme (MEIS).

(e) : ITPO allows the exhibitions to do business in all the exhibitions by promoting their products in the exhibitions. During the 35th India International Trade Fair held in November, 2015, some of the exhibitors have done the sale activity for which the DVAT registration was not obtained by them. Accordingly, DVAT Authority have

imposed a penalty of Rs.49.50 lakhs on ITPO vide the impugned notice of assessment of penalty issued by the VATO of the Ward-02 of the said Department on 24.11.2015 in form DVAT-24A under Section 33 read with Section 86(230) of the DVAT Act, 2004 and also penalized on individual exhibitors who failed to do the registration earlier. It is being appealed by ITPO stating (i) not every exhibitor do the sale activity, accordingly, making DVAT registration mandatory for all exhibitors may not be possible for ITPO (ii) the event is a trade event facilitated for the trade purpose. ITPO facilitated the DVAT official's presence during the trade fair by setting up their office within the trade fair premises and extended all facilities requested by DVAT Authorities.

(f) : Pragati Maidan complex is a prime location in the city and a large no. of visitors visit during the various fairs. There is always a perception of general security threat. Therefore, CISF was inducted in June 2014 with 97 sanctioned CISF personnel for access control. Apart from CISF, ITPO hires security personnel, fire guards and Civil Defence volunteers depending on the size of the fair. The local police also provide assistance during IITF.

(b) & (c) Prices of any agricultural products depends on various factors like domestic and international demand and supply situation, global stock position, quality standards in the importing countries, varieties traded, price competitiveness and food inflation, Minimum Support Price, overall inflation in economy etc. There is an Inter-Ministerial Committee which takes stock of the arrival of onion and modal prices prevailing in the important production and consumption centres and takes

appropriate decision of calibrating export through Minimum Export Price (MEP) on onion from time to time.

(a) & (b) Government regularly consults exporters on trade related issues. Before the announcement of Foreign Trade Policy 2015-20, government convened 41 meetings with the Organizations representing exporters from all sectors. Government also regularly engages with exporters through the open house meetings organized by Trade Organizations.

(c) Federation of Indian Export Organizations (FIEO) on Oct 7,2015 raised transactions cost related issues. Major issues raised were: High cost of credit, need for upward revision of the rates under the Merchandise Exports from India Scheme (MEIS), delay in refunds of Service Tax/Central Excise Rebate claims, exempted from Service Tax etc.

(d) Government informed FIEO of its commitment to bring down the transactions cost of undertaking exports. Government has introduced the following measures to bring down the transactions/ other cost:

- i) Introduction of the Interest Equalisation Scheme with effect from 1.4.2015- This will reduce the interest burden of all MSME and other eligible exporters,
- ii) Consolidation of merchandise exports incentive schemes- Number of schemes has been reduced from 6 in the earlier Foreign Trade Policy to just one. The new scheme is known as the Merchandise Exports from India Scheme (MEIS).
- iii) Increase in rates and country coverage of important products under the Merchandise Exports from India Scheme (MEIS) has been done on 29.10.2015

- iv) Reduction in the number of mandatory documents to 3 each for export and import. Earlier 7 documents were required for exports and 10 for imports.
- v) Expansion of the facility of online filing of export application/payment of fees at the Directorate General of Foreign Trade.
- vi) Extension of 24x7 Customs Clearance facility for export and imports to cover 18 sea ports and 17 air cargo complexes for specified cargo.
- vii)Online message exchange facility for issuance of no objection certificates has been established between Customs [JNPT (Nhava Sheva), ICD, Tughlakabad and ICD, Patparganj] and the Food Safety and Standards Authority of India (FSSAI) and the Department of Plant Protection, Quarantine and Storage (PQIS). This will help in faster clearance of goods.

Spice processing units and traders regularly export spices e.g. turmeric powder, coriander powder, chilli powder, dry ginger powder etc in various forms including value added forms and earn valuable foreign exchange for the country.

No shortage is expected in supply of major spices like chilli, ginger, turmeric, coriander etc. in the domestic market on account of export. The details of production and export of spices such as turmeric, coriander, chilli and ginger along with the percentage of export in production during the last three years is given at the Annexure 1.

(a) to (c): Directorate General of Anti-dumping & Allied Duties (DGAD) conducts antidumping investigations on the basis of duly substantiated petitions filed by domestic industry alleging dumping of goods into the country, causing injury to the domestic industry. The basic intent of the anti-dumping measures is to eliminate injury caused to the domestic industry by the unfair trade practices of dumping and to create a level playing field for the domestic industry vis-a-vis dumping by re-establishing a situation of open and fair competition in the Indian market. Based on the recommendations of DGAD, Department of Revenue has imposed anti-dumping duty on the following Stainless Steel products originating in or exported from respective countries as stated below:-

(b) to (d) The Government monitors the export performance of different sectors and takes need based measures from time to time, keeping in view the global economic environment. Department of Commerce/Directorate General of Foreign Trade engages with stake holders including Export Promotion Councils to assess the export sector situation.

Based on the assessments and feedback received from exporting community, Government has taken suitable measures to promote exports including by the labour intensive sectors, which include:

(i) The Foreign Trade Policy (FTP) 2015-20 introduced on 1st April, 2015, has implemented two new schemes, namely, 'Merchandise Exports from India Scheme'(MEIS) for incentivising export of specified goods to specified markets and 'Service Exports from India Scheme' (SEIS) for increasing exports of notified services from India. Recently in October, 2015, the government has reviewed and expanded country coverage and enhanced incentives for some lines under Merchandise Exports from India Scheme (MEIS) and included certain additional products for coverage.

- (ii) The Foreign Trade Policy 2015-20 has also introduced several measures for facilitating trade and improving `Ease of doing business' by reducing the number of mandatory documents required for export and import to three each. In order to facilitate faster processing and enable working in 24*7 mode, DGFT has facilitated submission of various applications and documents in online mode, as well as online payment of application fees through credit/debit cards and electronic fund transfer from 53 banks. CBEC has also facilitated integration of Plant Quarantine and FSSAI with EDI system of Customs for purposes of export and import. SEZ Online system has also been integrated with Custom's EDI system. These measures will facilitate trade by reducing transaction cost and time.
- (iii) The State Governments have been requested to develop their export strategy, appoint export commissioners, address infrastructure constraints restricting movement of goods, facilitate refund of VAT/Octroi/State level cess, address other issues relating to various clearances etc. and build capacity of new exporters, in order to promote exports.

It includes 752 tariff lines relating to Textiles, Ready Made Garments and Made Ups sector. Labour intensive products like Handloom, Coir, Jute, Textile related handicraft products, carpets, woollen shawls etc. have been provided support at maximum rate of 5%. Important lines of Ready Made Garments, Made Ups, and cotton fabrics are also covered. Other lines of textiles could not be supported, given the need to prioritize within the available resources. (c) & (d) The Government has received requests for grant of export incentives to the Copper Industry. MEIS incentivises 26 tariff lines at 8 digit level of copper and articles thereof. Copper Cathodes and Rods could not be included in the MEIS, given the need to prioritize within the available resources.

In addition to the four functional Border Haats, Government of India and Government of the People's Republic of Bangladesh have approved six more Border Haats- two in Tripura at Palbasti (Raghna) and Kamalpur (Dhalai) and four in Meghalaya at Bholaganj in East Khasi Hills, Nalikata in South West Khasi Hills, Shibbari in South Garo Hills and Ryngku in East Khasi Hills.

The Border Haats aim at promoting the wellbeing of the people dwelling in remote areas across the borders of two countries, by establishing traditional system of marketing the local produce through local markets.

(c) The operationalisation of the six Border Haats depends upon various factors including, inter-alia, the cooperation extended by the local authorities and the Government of the People's Republic of Bangladesh.
