Will the Minister of **COMMERCE & INDUSTRY** (विणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether the Government has any scheme to assist the States in promotion of exports and if so, the details thereof;
- (b) the details of total funds allocated to various States for export promotion, sector and State-wise during each of the last three years and the current year along with the steps taken by the Government to engage the States in export promotion;
- (c) the measures taken by the Government to improve the logistic constraints to achieve the export target of the country;
- (d) whether the Government has also made provisions for tax rebate for promotion of exports and if so, the details thereof; and
- (e) the value of rebate provided during the last three years along with the role of the said rebate in increasing the exports and the monitoring system in place to ensure proper utilisation of the said rebate?

a) to e): A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF LOK SABHA STARRED QUESTION NO. 102 FOR ANSWER ON 11th FEBRUARY, 2019 REGARDING "PROMOTION OF EXPORTS".

(a) & (b) The Government of India has recently launched a scheme namely 'Trade Infrastructure for Export Scheme (TIES)' w.e.f. FY 2017-18 with the objective to assist Central and State Government agencies in creation of appropriate infrastructure for growth of exports from the States. The scheme provides financial assistance to Central/State Government owned agencies (or their Joint Ventures with major stake-holding by them) for setting up or up-grading export infrastructure, subject to the project being compliant of the scheme guidelines. The scheme guidelines are available at https://commerce.gov.in.The Scheme can be availed by the States through their agencies, for export infrastructure projects with overwhelming export linkages like the Border Haats, Land customs stations, quality testing and certification labs, cold chains, trade promotion centres, dry ports, export warehousing and packaging, SEZs and ports/airports cargo terminuses.

Under the TIES Scheme, so far in total 24 export infrastructure projects have been provided financial assistance during FY 2017-18 and 2018-19. The state-wise and Year-wise details of projects, located in various States/UTs, is given at **Annexure-I & II.**

Also with the objective to engage with the State Governments on measures for promoting exports and create a trade enabling environment in the State, a Council for Trade Development and Promotion has been constituted under the chairmanship of the Union Commerce and Industry Minister, in which the Trade & Commerce Ministers of all the states are members. Regular annual meetings of the Council have been conducted to enable the States to articulate their views on the Foreign Trade Policy.

- (c) Improving logistics is an ongoing and continuous process. The Government reviews and removes the bottlenecks to make the logistics more efficient. Some of the recent measures taken have been
 - (i) In May, 2018, the Ministry of Shipping lifted restriction on foreign registered vessels for transportation of loaded or empty containers between Indian ports. This can lead to increase in container trade volumes in the country.
 - (ii) Implementation of 'Sagar Mala' and 'Bharat Mala' programmes are also expected to bring down logistics cost and improve export competitiveness.
 - (iii) Further cold chains, multi-modal logistics parks etc. have been included in the Harmonized Master List of Infrastructure sub-sectors' and has been granted infrastructure status in November 2017. This would enable the sector to avail infrastructure lending at terms with enhanced limits, access larger volume of funds as External Commercial Borrowings (ECB) and access longer tenure funds from insurance companies.
- (d) & (e): Yes Madam, provisions have been made under the Central Excise Act 1944 and rules made there under to provide rebate to exporters. To ensure that the

provisions for the rebate are not misused, suitable safeguards have been built in the law. The purpose of rebate of duty to exporters is to make our exports zero rated and therefore the exports become more competitive in the international markets. The value of rebate during the last three years is given below.

- (a) the area of land out of the land acquired for the Special Economic Zones (SEZs) which is not being utilised at present along with the locations thereof;
- (b) the reasons for the said land not being utilised for SEZs;
- (c) the reasons for the Union Government not suggesting the State Governments to transfer such land which was acquired for SEZs and is not being used for this purpose, to the owners of such land; and
- (d) the reaction of the Government in this regard?

a) to d): A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (d) OF LOK SABHA STARRED QUESTION NO. 104 FOR ANSWER ON 11th FEBRUARY, 2019 REGARDING "SPECIAL ECONOMIC ZONES".

(a) and (b): As per Entry No. 18 of the State list in the 7th Schedule to the Constitution of India, 'land' is a State subject. Land for setting up of Special Economic Zones (SEZs) is acquired by the State Government as per the policy and procedures of the respective State Governments. The Board of Approval (BoA) for SEZs only considers proposals for setting up of new SEZs which have been duly recommended by the State Government. In respect of 369 notified SEZs (including 7 Central Government SEZs and 11 State/Private Sector SEZs), 23779.20 hectares of land is vacant in these SEZs as on 30.08.2017. The details in this regard are at **Annexure**.

(c) and (d): De-notification of notified SEZs are carried out on the basis of No-objection from the State Government concerned. 'Land' being State subject, it is for the State Government to ensure utilization of land acquired for the purpose of setting up of SEZs. Setting up of Special Economic Zones (SEZs) is a long term process and delay in commencement of commercial operations of the SEZs may be due to various reasons which include time taken in getting approvals from statutory/State Government bodies, adverse business climate due to changed global economic situation, changes in fiscal incentives, etc. However, Central Government has advised State Governments to ensure maximum utilization of land acquired for the purpose of setting up of SEZs.

- (a) whether the Government is aware of the difficulties being faced by the domestic manufacturers of two wheeler alloy wheels;
- (b) if so, whether the Government is proposing any safeguards to protect the two wheeler alloy wheels manufacturers under 'Make in India' programme and if so, the details thereof;
- (c) if not, whether the Government in the past proposed/levied anti-dumping duty on the import of four wheelers/four wheeler alloy wheels;
- (d) if so, whether the Government is contemplating similar anti-dumping duty on import of two wheeler alloy wheels also, if so, the details thereof and the time by which it is likely to be done; and
- (e) whether the Government is also proposing maximum import price, as done for Steel, for two wheeler alloy wheels and if so, the details thereof?

ANSWER

THE MINISTER OF COMMERCE AND INDUSTRY (SHRI SURESH PRABHU)

a) to e): A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF LOK SABHA STARRED QUESTION NO. 106 FOR ANSWER ON 11th FEBRUARY, 2019 REGARDING "ANTI-DUMPING DUTY".

- (a): Difficulties being faced by the domestic manufacturers of two wheeler alloy wheels have been brought to the notice of the Government.
- (b): Make in India envisages various measures that have been put in place to create a business friendly manufacturing environment in India, which is available to manufacturers in this sector also. The sector also enjoys duty protection by way of 20% import duty on alloy wheels imports.
- (c): The Government has levied Anti-Dumping duty on "Cast Aluminium Alloy Wheels or Alloy Road Wheels used in Motor Vehicles, whether or not attached with their accessories, of a size in diameters ranging from 12 inches to 24 inches" originating in or exported from China PR, Korea and Thailand on 22.05.2015 for a period of five years from the date of imposition of provisional anti-dumping duty i.e. 11.04.2014 and the duty is valid up to 10.04.2019. Likewise, Anti-Dumping duty has also been imposed by the Government on "Flat Base Steel Wheels" originating in or exported from China PR on 13.09.2018 for a period of five years.
- (d): To provide a level playing field to domestic manufacturers and protect them against unfair trade practices, various trade remedial measures are available under the Customs Tariff Act, 1975 and the Rules made thereunder.

Directorate General of Trade Remedies (DGTR) initiates trade remedial investigation on the basis of a duly substantiated application filed by the domestic industrycontaining *inter alia* prima-facie evidence of dumping, subsidization or surge in imports causing material injury to the domestic industry. The proceedings of DGTR are quasi-judicial in nature and adequate opportunity is given to all interested parties during the course of investigation for making their submissions. DGTR critically analyzes the submissions and evidence on record and issues final findings containing its recommendationregarding imposition of appropriate trade remedial measure. Acting upon such recommendations of the DGTR, the Department of Revenue issues the notification regarding levy of provisional or definitive duties.

No Anti-Dumping petition has, so far, been filed in Directorate General of Trade Remedies (DGTR) by the Indian manufacturers of two wheeler alloy wheels.

(e): There is no prevalent concept of Maximum Import Price and no such proposal for two wheeler alloy wheels is under consideration.

(a)&(b) Yes, Madam. The Dispute Settlement Body (DSB) of WTO has ruled on 19 June 2015 that India's Sanitary and Phytosanitary (SPS) Measures on certain poultry and poultry products were not consistent with international standards as required under WTO Agreement on SPS Measures. Although, India has complied with the ruling, the United States alleging that India is still not compliant, has chosen to approach the Arbitrator at DSB for retaliation. India on its part has initiated Compliance Panel proceedings to prove its compliance with the recommendations of DSB.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY)

(a) Yes, Madam. The Government has introduced a comprehensive Agriculture Export Policy with the following vision:

"Harness export potential of Indian agriculture, through suitable policy instruments, to make India a global power in agriculture, and raise farmers' income."

Inter-alia, the objectives of the Agriculture Export policy are as under:

- (i) To diversify our export basket, destinations and boost high value and value added agricultural exports, including focus on perishables.
- (ii) To promote novel, indigenous, organic, ethnic, traditional and non-traditional Agri products exports.
- (iii) To provide an institutional mechanism for pursuing market access, tackling barriers and dealing with sanitary and phytosanitary issues.
- (iv) To strive to double India's share in world agri exports by integrating with global value chains.
- (v) Enable farmers to get benefit of export opportunities in overseas market.

The envisaged initiatives in the Agriculture Export Policy have been organised in two categories – Strategic and Operational – as detailed below:

(c) Yes, Madam. One of the objectives of the Agriculture Export Policy is - "to diversify our export basket, destinations and boost high value and value added agricultural exports, including focus on perishables."

India has remained at the lower end of the global agri export value chain given that majority of its exports are low value, raw or semi-processed and marketed in bulk. India is unable to export its vast horticultural produce due to lack of uniformity in quality, standardization and its inability to curtail losses across the value chain. Given the globalization of value chains, it is imperative that the country make concerted efforts to boost exports of high margin, value added and branded processed products. The Agriculture Export Policy envisages a paradigm shift from residual export after meeting domestic demand to targeted export according to preferences of overseas market.

(d) The State-wise data on exports is not validated by the Directorate General of Commercial Intelligence & Statistics (DGCI&S), as there is no scope for verifying the correctness of the state of origin code reported by the exporters.

LOK SABHA UNSTARRED QUESTION NO. 1164(H) TO BE ANSWERED ON 11th FEBRUARY, 2019

REMOVAL OF PRE-IMPORT CONDITION

- (b) & (c): Before the notification, under Advance Authorisation Scheme, IGST and Compensation Cess exemption was available, only if pre-import condition was adhered to. In other case, only refund route was available to the advance authorization holders. This notification enhances ease of doing business and is a trade facilitation measure. It also addresses the issue of blockage of funds for exporters availing Advance Authorisation Scheme.

The data in the above table reflect that India's merchandise export has a positive growth of 17.98% in June 2018 and merchandise import has also a positive growth of 20.91% in June 2018 as compared with the corresponding period of the previous year. The trade deficit has widened over the periods due to relative fluctuations in the imports and exports of different commodities, the global and domestic factors such as demand and supply in domestic and international markets, currency fluctuations, trade agreements between competing exporting countries with export destination countries, non-tariff barriers by export destination countries, cost of credit, logistics costs, etc.

Further, Department of Animal Husbandry, Dairying and Fisheries (DAHD&F)has also provided financial support to States/UTs for holistic development of fisheries which includes enhancing production and productivity, creation of infrastructure, thrust to export and welfare of fishers/farmers. Details of the fund released by

DAHD&F during the financial year 2016-17 to 2018-19 (upto 31.01.2019) under Blue Revolution Scheme is attached at **Annexure-I**.

- (c) No Madam. No support price has been fixed for marine products as there is a competition in the international market for marine products and the prices are market driven. Any external intervention on the prices is likely to jeopardize the exports from the country.
- (d) Yes Madam. Saudi Arabia, Kuwait, Canada, Australia and Thailand have imposed restriction/temporary ban on import of Indian shrimps due to bio security issues.
- (e) The trade restrictions have been taken up with the concerned countries through the Indian Embassies and further clarifications sought by the importing countries, have been furnished to them. The major cause for the trade restriction is the report of White Spot Syndrome Virus (WSSV) in certain areas of aquaculture. MPEDA has strengthened awareness campaigns among the fishery farmers for adopting Better Manufacturing Practices (BMP) in Aquaculture through Cluster farming. The campaigns are also conducted against the use of banned antibiotics in aquaculture.

- (a) whether the rubber industry will continue to grow faster, create more employment opportunities, increase exports and add to the economic output of India;
- (b) if so, whether the Government has assessed the potential of the rubber industry in respect of creation of employment and increase of export and if so, the details thereof;
- (c) whether the rubber industry is facing many issues which create hindrance in the growth of the industry and if so, the details thereof along with the details of various issues faced by rubber cultivators in the country including Kerala;
- (d) whether the Government has proposed or is developing a National Rubber Policy to address various issues concerning the sector with a view to boost productivity and also to ensure remunerative price for natural rubber;
- (e) if so, the details thereof along with the time by which a final decision is likely to be taken in this regard; and
- (f) whether the Government will consider to reduce the import of rubber to protect the struggling cultivators and if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY)

(a)& (b):Consumption of rubber (natural rubber, synthetic rubber and reclaimed rubber) by domestic rubber products manufacturing sector increased from 1.46 million tonnes in 2010-11 to 1.88 million tonnes in 2017-18& export of rubber products increased by 148% during the period providing/creating employment opportunities in the sector. Rubber Board has projected natural rubber production and consumption in 2030-31 as 1.41 million tonne and 2.04 million tonne respectively. Increase in rubber production and consumption would lead to creation of more employment and export. The Indian rubber industry provides the

maximum employment per unit capital invested in the Micro Small and Medium Enterprises (MSME) sector.

- (c): Rubber products manufacturing industry is faced with several issues like inadequacy of raw materials, low level of technology in non-tyre sector, competition from imported products etc. Rubber growers in Kerala and other states are confronted with issues such as low prices, shortage of skilled tappers, changing climate etc.
- (d) &(e): A Task Force was constituted to recommend short term solutions and long term strategies for mitigating the problems being faced by the rubber growers in the country including those in Kerala especially prevailing low prices, boosting production to bridge the gap between demand and supply, shortage of skilled tappers, changing climate etc., to coordinate and develop synergy with the various Ministries/ Departments of the Central Government and State Government and to suggest a policy on rubber. The Task Force submitted its report to this Department including recommendations on short term strategy and long term strategies for development of Rubber sector in the form of draft National Rubber Policy.
- (f): Import of goods is done by importers as per the applicable import policy related to the goods. Import of goods can be free, restricted or prohibited. Natural Rubber (NR) is free to be imported on payment of customs duty as there are no Quantitative Restrictions (QRs) on its import. The domestic NR priceis highly sensitive to import of NR. Therefore, to address this issue, the Government has increased the duty on import of dry rubber from "20% or Rs. 30 per kg whichever is lower" to "25% or Rs. 30 per kg whichever is lower" with effect from 30.4.2015 in order to create demand for locally produced rubber. The Government has also reduced the period of utilization of imported dry rubber under advance licensing scheme from 18 months to six months. To address various regulatory concerns, Director General of Foreign Trade (DGFT) has imposed port restriction on the import of Natural Rubber by restricting the port of entry to Chennai and NhavaSheva (Jawaharlal Nehru Port) from 20th January, 2016.

- (a) the details of measures to be taken by the Government to check the untimely deaths of children and commuters resulting from accidents due to chinese kite-flying strings (Manjha);
- (b) whether the Government proposes to ban the import and sale of Chinese kiteflying strings (Manjha) in the domestic market; and
- (c) if so, the details thereof along with the steps being taken by the Government in regard to the illegally imported Chinese kite-flying strings (Manjha)?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY)

[a] to [c]: Items are imported into India based on their classification under the Indian Trade Classification [Harmonized System], 2017 according to their characteristics. Import data on Plastic/Synthetic thread shows that it is imported under 4 different Chapter Heads i.e Chapter 39, 54, 55 and 56 of ITC(HS)2017. In addition, as Kite Flying Kit [Toy] containing such thread, it may find entry under Chapter 95 of ITC [HS]. These items are also produced domestically. However, abrasive string used for Kites [Manjha] is not classified separately, under any specific HS Code. As such separate import data and other related information is not available.

Accordingly, despite some reports of injuries to humans, animals and birds in some parts of the country, it has not been found feasible to regulate/restrict import of synthetic/plastic threads alone, which may have multiple uses, without imposing similar restriction/regulation on domestic sources, as it would violate India's commitments to the WTO. Moreover, Chinese manjha is a loose description, given to Kite threads made of Nylon and may not necessarily be imported from China.

However, as retail trade is a state subject, the State Governments have been requested to take appropriate action in the matter. As per the information available some State Government including NCT of Delhi, Uttar Pradesh, Karnataka, Andhra Pradesh and Maharashtra have banned procuring/distribution/sale/use of Nylon thread and other synthetic non-biodegradable threads used for kite flying.

TRADE OF ORGANIC FOOD ITEMS

1315. DR. PRABHAS KUMAR SINGH:

Will the Minister of **COMMERCE & INDUSTRY** (विणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) the details of the trade in organic food items during each of the last four years, itemwise indicating India's share in global trade in organic foods at present;
- (b) whether India's share in global trade of organic foods is very low despite farming and availability of organic food in the country;
- (c) if so, the details thereof along with the reasons therefor; and
- (d) the steps taken or proposed to be taken by the Government to increase India's share in global trade of organic food?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY)

- (a) Details of India's exports of organic products, during the last four years, are at Annexure -I.
- (b & c) India's share in estimated global trade of USD 90 Billion (source: FiBL) is only 0.55%. The reasons for India's low share are as under:
 - 1) Export of certified organic products has commenced relatively recently. Growth of the sector will take some time;
 - 2) Presently the major export markets are USA, EU and Canada. With opening up of certain new markets, export will increase;
 - 3) Inadequate and inconsistent supply of certified organic products as per market requirements;
 - 4) Unavailability of qualified/trained manpower both with State Government Certification Bodies (CBs) and in private sector CBs;
 - 5) Additional compliance requirements with respect to inspection and certification in major importing countries as well as requirement of product certification by some of the importing countries in addition to process certification;
 - 6) Negligible export in product categories such as value added products, livestock, poultry, apiculture & aquaculture products, animal feed processing & handling, mushroom, aquatic plants, seaweed, greenhouse products, etc.
- (d) The promotion of exports of organic products is a continuous process. The newly introduced Agriculture Export Policy provides an assurance that no restrictions will be placed on export of organic products. The Government has introduced national Programme for Organic Production (NPOP) for development of organic sector. The Agricultural & Processed Food Products Export Development Authority (APEDA),

an autonomous organisation under the administrative control of Department of Commerce, has been mandated with the implementation of NPOP and export promotion of organic products. APEDA provides assistance to the exporters of organic products under various components of its export promotion scheme.

(a) & (b): Yes Madam. Directorate General of Trade Remedies (DGTR) initiates trade remedial investigations on the basis of a duly substantiated application filed by the domestic producer with a prima-facie evidence of dumping/subsidization/surge in imports of goods into the country causing injury to the domestic industry. Such applications submitted by domestic industry are processed as per the procedure and within the time limits specified under the Customs Tariff Act, 1975 and the rules made there under. The details and outcomes of the investigations conducted during the last three years are given at **Annexure-I**.

(c):Latest available data on capacity and production of crude steel, cement and tyres (all categories) in India during the last year and current financial year is given in the table below:

Will the Minister of COMMERCE & INDUSTRY (विणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether an Exporters' Grievance Redressal Cell (GRC) to monitor specific complaints from exporters for quick redressal is available with the Government and if so, the details thereof;
- (b) the details of the complaints received and disposed off during each of the last three years by the GRC indicating the nature of the grievances lodged by the exporters;
- (c) whether any specific time frame has been fixed for disposal of the said complaints;
- (d) if so, the details thereof and if not, the reasons therefor; and
- (e) the other steps taken by the Government to boost exports by supporting exporters by various schemes?

ANSWER

- (a) Yes. The mechanism for redressal of exporter's grievances is available in the Directorate General of Foreign Trade (DGFT) as per the provisions contained in para 9.08 of the Handbook of Procedures (2015-20). Exporter's grievances are redressed through the mechanism of contact@DGFT link on the website of DGFT, CPGRAM, Policy Relaxation Committee, Niryat Bandhu and Twitter handle of DGFT.
- (b) Details of the complaints received and disposed off during each of the last three years are as under:

Grievances of the exporters generally pertain to difficulties faced by them in electronic data interchange, obtaining incentives and authorization, regularisation of the mistakes committed on their part, effecting import/export, interpretation of policy/procedures, relaxation of the policy/procedures in case of genuine hardship etc.

- (c) & (d): Generally all efforts are made to dispose complaints at the earliest. However, it is difficult to fix time frame for disposal of all types of complaints as it depends on the nature and complexity of the individual complaint.
- (e) Government has taken several steps to boost exports through various schemes such as Merchandise Export from India Scheme, Service Export from India Scheme, Duty Exemption /Remission Scheme, Duty Free Import Authorization Scheme, Scheme for Exporters of Gems and Jewellery, Export Promotion Capital Goods Scheme, Interest Equalisation Scheme and Refund of Duty Drawback, Terminal Excise Duty on Deemed Exports etc.

Will the Minister of COMMERCE & INDUSTRY (विणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether there is a huge potential for agriculture exports to boost the agriculture, horticulture, plantation, fisheries and dairy sectors and if so, the details thereof;
- (b) whether the Government is contemplating to identify districts possessing potential for particular industries and items for developing them as clusters for development of that sector;
- (c) if so, the details thereof;
- (d) whether the UAE, Saudi Arabia and some other countries have evinced interest in investing in India's agriculture sector;
- (e) if so, the details thereof along with the extent to which it will be helpful to fetch good price for agricultural produce; and
- (f) the other measures taken by the Government to increase the income of farmers and the success achieved in this regard so far?

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्री सी. आर. चौधरी)

- (a) India, with a large and diverse agriculture, is among the world's leading producer of cereals, milk, sugar, fruits and vegetables, spices, eggs and seafood products. Recent growth rates show that agri-food production is rising faster than growth in domestic demand, and volume of surplus for export is witnessing accelerated growth. This offers scope and opportunity for capturing overseas markets to earn foreign exchange and enable producers to earn higher prices for farm produce.
- (b & c) Under the recently introduced Agriculture Export Policy, several unique product-district clusters are identified for a more focused pre and post-harvest management of the production as well as in upgrading the supply chain to attain much higher levels of export from these clusters. These clusters have been identified based on the existing production

contributing to exports, exporters operations, scalability of operations, size of export market / India's share, awareness about SPS requirements, and potential for increase in export in short term. The list of such clusters is at Annexure-I.

- (d & e) Yes. Sir. Some companies from UAE and Saudi Arabia have evinced interest in investing in India's agriculture sector.
- (f) The Government is taking a number of measures to increase the income of farmers. In the Minimum Support Price (MSP) policy announced in 2018-19 season, the farmers are assured of a minimum of 50 percent as margin of profit.

Government has been implementing/reorienting various schemes for betterment of agriculture sector with four key elements: reducing input costs; ensuring fair price for the produce; reducing wastage; and creating alternate sources of income. Some of the major initiatives of the Government towards welfare of the farmers are Soil Health Cards (SHC), production and availability of quality seeds, Pradhan Mantri Krishi Sinchai Yojana (PMKSY), e- National Agriculture Market (e-NAM), Pradhan Mantri Fasal Bima Yojana (PMFBY), Paramparagat Krishi Vikas Yojana (PKVY) and National Mission for Sustainable Agriculture (NMSA). Moreover, Government is also promoting allied activities like dairying, poultry, beekeeping and fisheries, which will mitigate risks associated with dependence on agricultural crops through income supplementation.

The Government is promoting group farming amongst the farmers. Small and marginal farmers are mobilized to form Farmer Producer Organizations (FPOs) / Farmer Interest Group for aggregation and economies of scale. FPOs are eligible for financial assistance inter alia under Mission for Integrated Development of Horticulture and National Food Security Mission.

The Government has also approved a new Umbrella Scheme 'Pradhan Mantri Annadata Aay Sanrakshan Abhiyan' (PM-AASHA). The Scheme is aimed at ensuring remunerative prices to the farmers for their produce as announced in the Union Budget for 2018, which envisages scaling up procurement significantly from the current Kharif marketing season.

In the Interim Budget 2019-20, a new programme named "Pradhan Mantri Kisan Samman Nidhi (PM-KISAN)" has been announced. Under this programme, vulnerable landholding farmer families, having cultivable land upto 2 hectares, will be provided direct income support at the rate of Rs. 6,000 per year.

TOBACCO EXPORT TO CHINA

1330. SHRI R. DHRUVA NARAYANA:

Will the Minister of COMMERCE & INDUSTRY (विणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether the revival of the Phytosanitary Protocol with China will help to revitalise tobacco export to China;
- (b) if so, the details thereof;
- (c) whether this move will prove economically beneficial to the country; and
- (d) if so, the details thereof along with the details of said protocol?

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्री सी. आर. चौधरी)

- (a) & (b): Yes Madam. China is one of the largest importer of tobacco in the world, including Flue Cured Virgina (FCV) Tobacco. India is one of the major producer of FCV Tobacco and is significant exporter of the same. It is expected that signing of Protocol of Phytosanitary requirement for export of tobacco leaves from India to China will help India's tobacco export to China.
- (c): India's total export of unmanufactured tobacco during 2017-18 was to the tune of 181.59 million Kgs valued at Rs.3870.52 crores. It is expected that tobacco exports from India is likely to increase on account of tobacco export to China.
- (d) India has signed the Protocol of Phytosanitary requirements for the export of tobacco leaves from India to China, with the General Administration of Customs of the People's Republic of China (GACC) on 21.01.2019. The salient features of the protocol are as under:
 - ➤ The protocol was signed on 21.01.2019 and the same will be in force for a period of four years from the date of signing of the protocol.
 - The tobacco leaves exported to China, which must be produced in Andhra Pradesh and Karnataka of India and have been cured and re-dried, must comply with the relevant phytosanitary and sanitary laws and regulations of China, and meet the requirements as stipulated in the Protocol.

- The importers of tobacco must obtain the import quarantine permit from GACC before trade contracts are signed. The tobacco leaves must be securely packaged in airproof way to prevent the contamination of quarantine pests.
- ➤ Ministry of Agriculture & Farmers Welfare (MOA&FW) will take effective monitoring measures in the field to ensure that the tobacco producing area is free of tobacco blue mold.
- MOA&FW shall conduct export quarantine inspection for tobacco leaves. For the consignment of tobacco leaves which meets the requirement stipulated in this protocol, MOA&FW shall issue a Phytosanitary Certificate according to the standards of International Plant Protection Convention (IPPC).

- (a) whether in the wake of growing protectionism globally, the Union Government, State Governments and industry representatives along with exporters/Ministry officials have recently discussed ways to boost the country's exports;
- (b) if so, the details of the persons who attended the meeting and the discussions held in the meeting along with the outcome thereof and the steps taken to enhance exports;
- (c) whether the Union Government has advised all the States to formulate their export policies and appoint Export Commissioners;
- (d) if so, the details of the States which have acted upon the advice of the Union Government; and
- (e) the extent to which the growing trade tensions between the US and China have any impact on our trade growth?

ANSWER

- (a) &(b): Yes, Madam. Amongst other initiatives, the 4th Meeting of the Council for Trade Development and Promotion was held on 10th January, 2019 under the Chairmanship of Hon'ble Commerce & Industry Minister. Ministers from 09 States and representatives of other State Governments, Line Ministries and leading Industry Bodies attended the meeting. In the course of the meeting, various issues / bottlenecks impeding our exports were discussed and deliberated. The states were also appraised of the recent Agriculture Export Policy and other initiatives where both centre and State could partner in boosting exports from the Country.
- (c) & (d) : The Government has requested all States to develop an Export Strategy for the State and nominate a Senior Officer as the Export Commissioner, who would coordinate all export efforts, required from the different agencies of the State

Government. 15 States have informed that they have formulated their export strategy. These are Chhattisgarh, Tamil Nadu, Jammu & Kashmir, Assam, Tripura, Gujarat, Haryana, Manipur, Uttar Pradesh, Madhya Pradesh, Jharkhand, Mizoram, Nagaland, Meghalaya and Odisha.

Further, 26 States, viz. Andhra Pradesh, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Manipur, Mizoram, Nagaland, Odisha, Punjab, Rajasthan, Sikkim, Tamil Nadu, Telangana, Tripura, Uttar Pradesh, Assam, West Bengal, Bihar, Goa, Chhattisgarh and Gujarat have informed that they have nominated an Export Commissioner in their State.

(e): The current trade stand off between US and China is likely to have its impact on the imports and exports of other countries, including India and may bring about a shift in trading patterns globally. The retaliatory tariffs between US and China provide a window of opportunity for enhancing India's Exports to China and US, particularly in products in which India is competitive and to the extent our available production capacity and exportable surpluses allow. The latest data of our trade with China reflect a measure of success that we have achieved in increasing our exports to China

Out of which, two proposals are in the state of Andhra Pradesh and one's in the state of Telangana. The details of the proposals are at **Annexure**.

- (b) As import policy of Natural Rubber is 'free' subject to port restriction, no license is required for import of Natural Rubber.
- (c) Import of natural rubber is allowed through sea ports of Nhava Sheva and Chennai since 20 January, 2016 with a view to protecting the interests of domestic rubber growers. However, port restriction is not applicable for import of natural rubber under Advance Authorisation.
- (d) Requests have been received for allowing imports of Natural Rubber through the ports namely Tuticorin, Mundra, Kattupalli and Kamarajar Port. However, the requests have been turned down.
