Will the Minister of COMMERCE & INDUSTRY (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) whether it is true that the Government is going to clear Rs. 56,000 crore dues to exporters under various Government schemes;
- (b) if so, the details of schemes under which Government owes to exporters and how many MSME exporters are going to be benefited therefrom;
- (c) the details of exporters from Telangana whose dues have to be cleared; and
- (d) the efforts being made by the Ministry to achieve the target of exporting US \$ 400 billion in 2021-22?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

- (a) & (b) Government has released Rs 56,027 crore in order to clear pending export incentive dues to exporters, which is for various Schemes namely: Merchandise Exports from India Scheme (MEIS) Rs 33,010 crore, Service Exports from India Scheme (SEIS) Rs 10,002 crore, Rebate of State and Central Taxes and Levies (RoSCTL) Rs 5,286 crore, Rebate of State Levies (RoSL) Rs 330 crore, Remission of Duties and Taxes on Exported Products (RoDTEP) Rs 2,568 crore and other legacy Schemes like Target Plus Scheme (TPS), Focus Product Scheme (FPS) etc. Rs 4,831 crore. This includes support for exports made under RoDTEP and RoSCTL Schemes during the 4th quarter of FY 2020-21. It is estimated that such benefits would be disbursed to more than 45,000 exporters, out of which around 98% may fall in the Micro, Small and Medium Enterprises (MSME) category.
- (c) Clearance of dues under these Schemes is dependent on meeting the eligibility criteria by the applicant exporter, whose applications are scrutinized for any deficiency. The process of approval of complete applications under these Schemes varies. In certain Schemes, such

- as MEIS, ROSCTL and ROSL, online applications are largely system approved, whereas for SEIS, TPS, FPS online applications require manual scrutiny and examination of documents. Accordingly the detail of exporters' dues state-wise is not maintained.
- (d) To reach the target, some of the key schemes/interventions taken by the Government are:
 - i. The Foreign Trade Policy 2015-20 has been extended upto 31.03.2022 to provide a stable regime during the COVID-19 pandemic, wherein Schemes such as the Advance Authorization Scheme and the Export Promotion Capital Goods (EPCG) Scheme are being implemented to enable duty free import of raw materials and capital goods for export production.
 - ii. Remission of Duties and Taxes on Exported Products (RoDTEP) Scheme has been introduced with a budget of Rs 12,454 crore for FY 2021-22.
 - iii. Rebate of State and Central Levies and Taxes (RoSCTL) Scheme for apparel and madeup exports has been extended till March 2024 with existing rates.
 - iv. Transport and Marketing Assistance (TMA) scheme for specified agriculture products is being implemented to provide assistance for the international component of freight and marketing of agricultural produce and to promote brand recognition for Indian agricultural products in the specified overseas markets.
 - v. A common digital platform for Certificate of Origin (CoO) has been launched to increase Free Trade Agreement (FTA) utilization by exporters.
 - vi. Monthly monitoring of exports for 200 countries and 31 commodity groups is being done.
- vii. Under the aegis of "Azadi Ka Amrit Mahotsav", Vanijya Saptah was celebrated during 21-26th September 2021 to reach out to members of industry, exporters, association and State/Union Territory Governments for awareness and interaction on exports and various export related issues.
- viii. In order to leverage full export potential, districts are being promoted as Exports Hubs by identifying products and services with export potential of each district.
 - ix. Exports of services is being supported through negotiating meaningful market access through multilateral, regional and bilateral trade agreements and through participation in and organization of international fairs/exhibitions like the Global Exhibition on Services.
 - x. An 'Action Plan for Champion Sectors in Services' to give focused attention to identified Champion Services Sectors through identified nodal Ministries/Departments is also in place.
- xi. Assistance is being extended to exporters under the Market Access Initiative (MAI) scheme for various activities such as export market research, product development, product registration, organizing / participating in fairs, exhibitions and Buyer Seller Meets (BSMs) abroad, Reverse Buyer Seller Meets etc.
- xii. In order to have a coordinated and focused attention on development of export infrastructure, a working group on infrastructure up-gradation has been constituted under National Committee on Trade Facilitation (NCTF) and a National Trade Facilitation Action Plan (NTFAP) has been formulated. This includes measures for improving road and rail connectivity to ports and smart gates at sea ports.

- (a) The National Export Insurance Account (NEIA) Trust aims to ensure the availability of credit risk cover for projects and other high-value exports, which are desirable from the point of view of national interest, but which ECGC is unable to underwrite due to capacity constraints or at terms, which are different from its regular policies. NEIA provides additional support to the insurance cover provided by ECGC for project exports making Indian project exporters more competitive and gain a stronger foothold in various jurisdictions, highlighting India's capabilities to execute large projects abroad.
- (b) Yes, Sir. Government has approved financial aid for the period from 2021-22 to 2025-26 to NEIA Trust.

- (c) Government has approved Grant-in-aid infusion of Rs.1,650 crore into NEIA Trust during 2021-22 to 2025-26.
- (d) No, Sir.
- (e) In view of the reply at (d) above, question does not arise.

- (a) Yes Sir, the Central Public Sector Undertakings (CPSUs) under the Ministry have been allocating funds for taking up projects under the framework for CSR (Corporate Social Responsibility), as per the guidelines of Department of Public Enterprises and the provisions of the Companies Act, 2013.
- (b) to (f) The details of total CSR funds allocated and spent on projects head-wise and location-wise during the last three years by CPSUs under the Ministry may be seen at Annexure-I. The location-wise data on number of beneficiaries is difficult to compile for projects like common public utilities, contributions to public welfare funds etc.

Department of Public Enterprises has issued guidelines to all administrative Ministries and CPSUs for adopting a theme based focused approach on CSR expenditure by the CPSUs.

The thrust of CSR spending under many projects is for upliftment of marginalized and underprivileged sections of society, including backward and scheduled caste/tribe dominated areas of the country.

As per CSR provisions in Section 135 of the Companies Act, 2013 ('Act') and Companies (CSR Policy) Rules, 2014 notified thereunder, the management of CPSUs may decide to undertake CSR activities, as per the eligible activities listed in Schedule-VII of the Act, in any part of the country, including for socio-economic development and welfare of backward and scheduled caste/tribe dominated areas etc.

(a)to b): The trade data of India's exports to and imports from China from FY 2014-15 to FY 2021-22 is as under:

- (c) to d): The imports from China have increased from USD 60.41 billion in 2014-15 to USD 65.21 billion in 2020-21, exhibiting an increase of 7.94% over 6 years. However, the imports were static between 2019-20 & 2020-21. The major items of import from China are products such as telecom instruments, computer hardware and peripherals, fertilizers, electronic components/ instruments, project goods, organic chemicals, drug intermediates, consumer electronics, electrical machinery etc. Many of these imported items are used for meeting the demand of fast expanding sectors like telecom and power in India. Some of our imports from China like the Active Pharmaceutical Ingredients (APIs) and drug formulations provide the Indian pharma industry raw material for producing finished goods which are also exported out of India. The details of India's imports from China, principal commodity wise and value wise during the last seven years and the current year is given in Annexure-I.
- (e) to (f): The exports from India to China have increased from USD 11.96 billion in 2014-15 to USD 21.19 billion in 2020-21, exhibiting an increase of 77.17% in 6 years.
- (g) The Government of India has made sustained efforts to achieve a more balanced trade with China, including bilateral engagements to address the non-tariff barriers on Indian exports to China. The Government has also launched schemes such as Production Linked Incentive Schemes (PLIs) to promote domestic manufacturing capacities in critical sectors such as Key Starting Materials/Drug Intermediates, Active Pharmaceutical Ingredients apart from electronic components & mobiles, white goods (ACs and LEDs), Specialty Steel, Drones and Drone Components etc. These schemes will promote domestic manufacturing capacities and attract investment and reduce dependency on imports from China.

(a) to (c): Export Promotion Councils (EPCs) are organizations of exporters, set up under the Societies Registration Act/ Companies Act, with the objective of promoting Indian exports. The councils are responsible for promotion of a particular group of products/ projects/services as given in Appendix 2T of the Foreign Trade Policy (FTP) 2015-2020. The list of 14 such EPCs affiliated to the Department of Commerce is at **Annexure**. Regular joint meetings with the councils to facilitate interactions with exporters and to assess performance of the councils are held. The accounts of the councils are subject to mandatory audit. The review reports of performance of the councils are laid in the Parliament along with Annual Report each year.

- (a) whether export-oriented production clusters are proposed to be established in Wayanad parliamentary constituency under the Agriculture Export Policy and if so, the details thereof, including the status of implementation;
- (b) the details of the initiatives are being undertaken to strengthen infrastructure and logistics for promotion of agricultural export in Wayanad parliamentary constituency;
- (c) whether any assistance has been provided to Kerala under the Trade Infrastructure for Export Scheme for establishment of Spice Parks and if so, the details thereof;
- (d) the details of the measures are being taken by the Government to ensure the effective participation of small and medium farmers in the production clusters;
- (e) whether any initiatives are being undertaken by the Government to promote the export of indigenous and tribal products; and
- (f) if so, the details thereof, including programs being undertaken in Kerala?

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्रीमती अनुप्रिया पटेल)

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

(a) Wayanad district has been identified as a cluster under the Agriculture Export Policy for development and promotion of exports of three products viz. Banana, Turmeric and Pepper under Agri Export Policy (AEP). District level Cluster Facilitation Committee has been constituted under the chairmanship of District Collector to oversee the development of cluster. Initial rounds of meetings with the stakeholders have been conducted. The State Nodal agency, Vegetable and Fruit Promotion Council Keralam (VFPCK) has organized the Capacity building program for the concerned stakeholders in the Banana Cluster comprising Wayanad, Thrissur and Thiruvananthapuram. Spices Board is coordinating with State Agriculture /

Horticulture Departments of Kerala and has provided technical support in preparing the Action Plan and a document related to good agricultural practices for various crops.

Under the District as Export Hub initiative Malabar Pepper, Banana, Wayanad Jeerakasala Rice, Wayanad Gandhakasala Rice, Wayanaad Robusta Coffee, Spice products, Tea and Coffee have been identified as the products with export potential for Wayanad district of Kerala.

- (b) APEDA has provided financial assistance of Rs. 430.92 lakhs to Vegetable and Fruit Promotion Council Keralam (VFPCK) under APEDA infrastructure scheme for establishment of Vegetables & fruits packhouse at Wayanad. Packhouse at Wayanad has become operational in the year 2016-17.
- (c) Spices Board has established a Spices Park at Puttady in Idukki district of Kerala. However, no assistance under Trade Infrastructure for Export Scheme (TIES) has been provided for establishment of Spices Parks in Kerala.
- (d) to (f) The Agricultural & Processed Food Products Export Development Authority (APEDA) has set up a Regional Office in Kochi in May 2021. APEDA has been working closely with the district officials of these clusters and other stakeholders to sensitize the farmers to enhance the quality of the produce for export purposes. Following initiatives have been taken:
 - Sensitization Programme for SC/ST FPOs in the State of Kerala was organised virtually on 26th June 2021.
 - Interactive meeting with FPO's of Kerala to identify the issues in exporting their potential products on 13th August 2021.
 - Interactive meeting with exporters &Farmers/FPOs of Rice exports was organised on 8th September 2021.
 - A virtual capacity building program was organized by APEDA in association with Department of Agriculture, Govt. of Kerala, Department of Industries & Commerce, Govt. of Kerala, Kerala Agricultural University, NABARD, NAFED, SFAC & VFPCK for FPOs/Cooperative societies/farmers of Kerala on 26th September 2021.
 - Organised a farmer-scientists interface on GI-Tagged rice varieties in association with Kerala Agricultural University, Thrissur to emphasize the export-oriented production of GI tagged rice varieties in Kerala on 12th October 2021.
 - A sensitisation programme on APEDA's new financial assistance schemes 2021-22 to 2025-26 was organised on 17th November 2021 in Ernakulam and on 19th November 2021 in Thiruvananthapuram.
 - Sensitisation meetings/programs have been organized in the Banana cluster in association with State departments, SAUs, KVKs, NABARD for identification of progressive Farmer groups and strengthening the export linkage of FPOs/FPCs.
 - The FPOs formed under the clusters are concentrating on induction of small and marginal farmers who constitute a majority in the farmers in Kerala. Export production protocol for banana has been developed by National Research Centre for Banana (NRCB) and is being disseminated among the farmers to ensure availability of export quality produce.

Spices Board has also established a field office in Kalpetta of Wayanad District for implementation of various programs for post-harvest management and quality improvement of Pepper, turmeric and other spices. The Board is implementing Post Harvest Improvement programs, viz, Supply of Pepper threshers, Turmeric boilers & polishers etc, at a subsidized rate to the pepper and turmeric growers and also providing quality improvement training and extension advisory services to the stakeholders for improving the quality of pepper and turmeric for export.

Under a joint venture by the ICAR-National Research Centre on Banana, Tiruchirappalli, Tamil Nadu and Vegetable and Fruit Promotion Council Keralam, Kochi, Kerala, The ICAR-NRC on Banana imparted hands-on-training to the Banana farmers from Thrissur District on the scientific cultivation of Nendran following Good Agricultural Practices to produce export quality Nendran Bananas. Consignments of Nendran Bananas have been exported to UK and Singapore. APEDA has also facilitated exports of value added products of Jackfruit and Passion Fruit.

Spices Board is implementing a Project 'Integrated Development of Small Cardamom in Aranamala Tribal Settlement of Wayanad district in Kerala during the period from 2020 to 2022, with support from Dept of Tribal Development, Govt of Kerala. The project with components such as area expansion, Installation of spice Curing Device, Quality Improvement Training programs (QITP), Extension Advisory support, Exposure Visits etc aims to benefit capacity building of 32 tribal families in Aranamala Tribal, with a financial outlay of Rs 11.71 lakh.

Under 'Districts as Export Hubs Initiative', Districts Export Action Plans are being prepared of such identified products and services for overseas markets, which includes specific actions required to support local exporters / manufacturers in producing/manufacturing identified products in adequate quantity and with the requisite quality, for reaching potential buyers outside India. These plans also include identifying and addressing challenges for exports of the such identified products/services, improving supply chains, market accessibility and handholding for increasing exports.

(a) & (b): Six cases were detected by the Tea Board where the imported teas were found to be non-compliant with the FSSAI-specified parameters. The Tea Board seized and destroyed the teas. The details of such cases during each of the last three years are given below:

- (c): The details of country-wise import of tea during the last three years are given at Annexure.
- (d) to (f): The Tea Board has issued instructions on 11.11.2021 directing all importers and buyers of tea to ensure that origin of imported tea to be mentioned in all their sale invoices and not to pass off imported tea as teas of Indian origin. All distributors and blenders of tea have been directed that the label should clearly indicate on the packaging that the contents of the blended Tea are imported, giving the source of origin of Imported tea irrespective of whether the imported tea has been bought directly or through an intermediary. All importers importing teas into India for distribution in India shall inform about the place of storage of such imported tea to the nearest Tea Board Office within 24 hours of entry of such teas into India. The tea buyers have been directed not to blend imported tea with teas of Darjeeling/Kangra/Assam (Orthodox)/Nilgiri (Orthothodox).

Food Safety and Standards Authority of India (FSSAI) and field formations of Customs are enforcing the provisions related to rule of origin, Sanitary and Phytosanitary certificates issued by appropriate authorities at point of entry.

- (a) Yes, Sir.
- (b) The Department of Commerce is implementing Trade Infrastructure for Export Scheme (TIES), under which assistance is provided for creating infrastructure for exports, including storage facilities required for export of grains. The Agricultural & Processed Products Export Development Authority (APEDA) also provides assistance for creation of export related infrastructure under its export promotion scheme.

Ensuring that our agriculture exports meet the requirements of importing countries is a continuous process. APEDA regularly holds outreach and capacity building programmes to educate farmers and other stakeholders on measures required to meet specific requirements of importing countries for various products. Mandatory testing and traceability systems have also been put in place for specific products and specific markets to ensure that requirements of the importing countries are met.

Some sanitary and phytosanitary measures in the form of setting very low Maximum Residue Level (MRL) of different chemical substances in agri products have been put in place by European Union (EU). The Government has been taking up this issue with EU in all bilateral discussions and pressing for setting MRLs based on scientific risk assessment and international standards such as CODEX etc.

(c) Does not arise in view of (a) and (b) above.

(a) and (b) The natural rubber producers in Kerala are getting adequate price for their product vis-a vis expenditure. Domestic Natural Rubber prices have increased in the country in the recent past and the monthly average price for the RSS4 grade natural rubber in Kerala during October 2021 was Rs. 171.14 per kg, against the tentative cost of production i.e. Rs 99.46 per kg, including all paid out costs, interest on working capital and depreciation of fixed assets.

As domestic NR price is highly sensitive and is linked to prevailing international prices of natural rubber, the Government has been taking steps from time to time to ensure that domestic farmers get remunerative prices for their produce.

(c) Total area under rubber cultivation has not decreased during the last five years. In the state of Kerala, it has almost been static as given in the following table:

(a): Tea Board promotes Indian Tea as a brand and its various varieties such as Darjeeling, Assam, Nilgiri, Sikkim, Kangra, Dooars-Terai and Tripura various platforms i.e. Tea Board website, media, promotional programs, Buyer Seller Meets, awareness campaign, Indian Missions abroad wherein a detailed description uniqueness/characteristics & health benefits of Indian teas are displayed. Branding of Indian Tea and its varieties is also done through various stakeholders of Tea Industry. Tea Board has obtained GI (Geographical Indication) for three different unique regional teas namely, Darjeeling, Assam (Orthodox) and Nilgiri (Orthodox) for premium teas of India. Further, in order to strengthen the identity of Indian tea, the Tea Board has registered logos for Indian Tea as well as other teas viz., Assam, Nilgiri, Dooars -Terai, Tripura and Sikkim.

- (b) & (c): Teas are allowed to be imported into India. The percentage of tea import to total domestic production is about 2%, which is mainly meant for re-export after value addition including blending. The Tea Board has issued instructions on 11.11.2021 directing not to blend imported tea with teas of Darjeeling (West Bengal)/Kangra/Assam (Orthodox)/Nilgiri (Orthodox).
 - (d): The Government of India does not export or import tea.

- **(b) & (c):** Niryat Bandhu Scheme has been allocated Rs. 5.45 Crore in last 5 years (2016-17 to 2020-21). An amount of Rs. 4.04 Crore has been utilized during this period and 65,184

(a) to (c): Yes Sir. On 23 September, 2021 India has introduced a document at the WTO containing 'Polluter Pays' principle for fisheries subsidies negotiations. It proposes a moratorium on subsidies by distant water fishing nations for fishing and fishing related activities beyond their Exclusive Economic Zone (EEZ) and also seeks reduction commitments on distant water fishing capacity by these nations.

In these negotiations, India has also sought policy space to support low income, resource-poor or livelihood fishing or fishing related activities up to our EEZ, to develop and modernize our fisheries sector and for expanding our fishing activities in the high seas.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

- (a): Yes Sir.
- (b): The details are as below:
 - (i) Government has approved capital infusion of Rs.4,400 crore into ECGC during the period from 2021-22 to 2025-26.
 - (ii) Government has approved Grant-in-aid infusion of Rs.1,650 crore into National Export Insurance Account (NEIA) Trust during 2021-22 to 2025-26.
 - (iii) Capital infusion in ECGC will increase its capacity to underwrite risks up to Rs.88,000 crore and this will enable ECGC to issue covers that can support additional exports of Rs.5.28 lakh crore over the five-year period in line with the existing pattern. With the Grant-in Aid infusion in the NEIA Trust, it will be able to support project exports worth up to Rs.33,000 crore. Cumulatively, an additional export of Rs.5.61 lakh crore over the next five years are likely to be facilitated by the approval.

- (c): Yes Sir. Department of Investment and Public Asset Management (DIPAM) is in the process of implementing the Government's decision.
- (d): Yes Sir.
- (e): As per the report on 'Export to Jobs' published by World Bank and International Labour Organisation in February 2019, ₹5.28 lakh crore of additional exports (estimated support by ECGC) will lead to formalization of 2.6 lakh workers. The total number of workers (both formal and informal) will increase by 59 lakhs as per the report. Further, Rs. ₹33,000 Crore of additional exports (estimated support by NEIA) will help create 2.6 lakh new jobs, including around 12,000 in formal sector. Thus, the total additional jobs, in both formal and informal sectors, that can be created over the next five years are estimated to be 61.6 lakh.

- (a): The DGTR has recommended to the Central Government (Department of Revenue) imposition of anti-dumping duty on the imports of dumped goods causing injury to the domestic industry. The DGTR carries out anti-dumping investigation in relation to the importation of dumped goods only as provided in the law.
- **(b):** The details of the recommendations to impose or not to impose the anti-dumping duty during the past five years are attached herewith at **Annexure I**.
- (c) & (d): Sir, the details thereof are available in Annexure I.
- (e): The DGTR is only a recommendatory body and makes its recommendations to the Central Government based on the facts presented before it and arrived thorough an open and inclusive process. The Department of Revenue comprehensively examines the recommendations taking into account the overall public interest and other relevant conditions like interest of the applicant industry, other Indian producers and downstream user industry for taking a view.
