The imports from China have increased from USD 60.41 billion in 2014-15 to USD 65.21 billion in 2020-21, exhibiting marginal increase of 7.94% over 2014-15. However, the imports were static between 2019-20 & 2020-21. For the 7 years period prior to 2014-15, the imports from China increased from USD 17.47 billion in 2006-07 to USD 51.03 billion in 2013-14 exhibiting an increase of 192%. The major items of import from China are products such as telecom instruments, computer hardware and peripherals, fertilizers, electronic components/ instruments, project goods, organic chemicals, drug intermediates, consumer electronics, electrical machinery etc. Some of our imports from China like the Active Pharmaceutical Ingredients (APIs) and drug formulations provide the Indian pharma industry raw material for producing finished goods which are also exported out of India.

India's exports to China are growing steadily. The exports to China increased from USD 11.93 billion in 2014-15 to USD 21.19 billion in 2020-21, exhibiting an increase of 77.6% over 2014-15. The commodities exhibiting increase in exports include engineering goods, petroleum products, organic and inorganic chemicals, electronic goods, cotton yarn, marine products, minerals and ores etc. The Government of India has made sustained efforts to achieve a more balanced trade with China, including bilateral engagements to address the trade issues with China.

(a) The Department of Commerce, Government of India is implementing a scheme namely 'Trade Infrastructure for Export Scheme (TIES)' w.e.f. FY 2017-18 with the objective of assisting Central and State Government agencies in the creation of appropriate infrastructure for growth of exports. Under the scheme, financial assistance in the form of grant-in-aid is provided to Central/State Government owned agencies for setting up or up-grading export infrastructure. The Scheme guidelines are available at <u>https://commerce.gov.in/trade-promotion/trade-promotion-assistance/</u>.

The scheme has been further extended for the period 2021-22 to 2025-26 with a total outlay of Rs 360 crore. A total of 51 projects having grant component of approx. Rs 548 crore, have been sanctioned under TIES till the end of January, 2022. Out of these projects, 13 projects are already completed.

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF LOK SABHA STARRED QUESTION NO. 11 FOR ANSWER ON 02<sup>nd</sup> FEBRUARY, 2022 REGARDING "SEZ POLICY".

(a): The Special Economic Zones (SEZs) policy was launched in April, 2000 as part of the extant Foreign Trade Policy, 2000-05 (FTP 2000-05). The Special Economic Zones Act, 2005, was passed by Parliament in May, 2005 which received Presidential assent on the 23rd of June, 2005. The SEZ Rules, 2006 came into effect on 10th February, 2006. The salient features of the SEZ Act, 2005 are:-

- (i) A designated duty free enclave to be treated as a territory outside the Customs territory of India for the purpose of authorised operations in the SEZ;
- (ii) No licence required for imports into SEZ;
- (iii) Single Window Clearance at the level of Board of Approval (BOA) and Unit Approval Committee (UAC);
- (iv) SEZ Units are required to achieve Positive Net Foreign Exchange (NFE) to be calculated cumulatively for a period of five years from the commencement of production;
- Supply of goods from SEZ units to Domestic Tariff Area (DTA) is allowed on payment of Customs duties including anti-dumping, countervailing and safeguard duties under the Customs Tariff Act, 1975, where applicable, as leviable on such goods when imported;
- (vi) No routine examination by Customs authorities of export/import cargo;
- (vii) Dedicated Customs wing for fast clearance.
- (viii) SEZ Developers /Co-Developers and Units enjoy Direct Tax and Indirect Tax benefits as prescribed in the SEZ Act, 2005.
- (b) and (c): No Sir.

(d) and (e): Review of SEZ policy is an on-going process and on the basis of inputs/suggestions received from stakeholders on the policy and operational framework of the SEZs, Government periodically takes necessary measures for facilitating smooth and effective implementation of the SEZ Act/Rules. Amendments carried out in the SEZ Act, 2005 and SEZ Rules, 2006 during the last three years are at **Annexure.** 

# Annexure to the Lok Sabha Starred Question No. 11 for 2<sup>nd</sup> February, 2022

Amendments carried out in the SEZ Act, 2005 and SEZ Rules, 2006 during the last three years:

#### 1. Amendments carried out in the SEZ Act, 2005:

Amendments carried on  $8^{th}$  July, 2019 for enabling Trusts and any other entity notified by the Central Government to set up units, definition of persons in Section 2(v) has been amended through the Special Economic Zones (Amendment) Bill, 2019. The bill got assent of President of India on 06.07.2019.

### 2. Amendments carried out in the SEZ Rules, 2006:

#### (a) Amendment carried out on 31st January, 2019:-

In Rule 42(1)(ii)(h) of the SEZs following amendment has been made:

Provided further that in case of a gems and jewellery unit, studded gold jewellery, silver jewellery and imitation jewellery, the finished goods requiring further processing or semi-finished goods, taken outside the Special Economic Zone for sub-contracting by the unit, shall be brought back into the unit within forty-five days.

#### (b) Amendment carried out on 7<sup>th</sup> March, 2019:-

In the backdrop of amendment carried on 19th September, 2018, suggestions from stakeholders were received to further amend the SEZ Rules and accordingly, the amendment were carried out including the amendment in rule 53 regarding method of calculation of Net Foreign Exchange (NFE) for the Units in SEZs.

#### (c) Amendment carried out on 17<sup>th</sup> December, 2019:

For utilization of the vacant spaces in SEZs, removal of distinction between sector specific and multi sector requirement, an amendment vide notification G.S.R. 940(E) dated 17th December, 2019 has been carried out for encouraging more investment and growth in exports.

#### (d) Amendment carried out on 31<sup>st</sup> December, 2019:

Rule 53A has been inserted to facilitate the calculation of net foreign exchange for a unit in an International Financial Service Center in view of its special nature.

#### (e) Amendment carried out on 23<sup>rd</sup> October, 2020:

In Rule 24(3) of the SEZs following proviso has been made:

Provided further that in case of supplies from Domestic Tariff Area to foreign suppliers in Free Trade and Warehousing Zone, the drawback or any other similar benefit Scheme shall be admissible where the payments are made in foreign currency by the foreign supplier to Domestic Tariff Area subject to sub-rule (5) of rule 18 of the said rules.

#### (f) Amendment carried out on 16<sup>th</sup> June, 2021:

After Rule 21 of the SEZs following rule has been inserted, namely:-

# 21A. Setting up of Unit by Multilateral or Unilateral or International agencies in International Financial Services Centre:-

- (1) A Multilateral agency or Unilateral agency or International agency notified under the United Nations (Privileges and Immunities) Act, 1947 (46 of 1947) shall be allowed to set up their local or regional office in the International Financial Services Centre as an Unit.
- (2) The application for setting up and operation of such Unit in the International Financial Services Centre shall be made before the Board of Approval through the concerned Development Commissioner.
- (3) The terms and conditions for setting up and operations by such Units shall be laid down by the Board of Approval based on the recommendation of the Development Commissioner.
- (4) Notwithstanding anything contained under these Rules, the Board of Approval may exempt such Units from any provisions of these Rules including provisions relating to positive Net Foreign Exchange earning or filing of Annual Performance Report or such other exemption, based on the recommendation of the Development Commissioner.
- (5) The proposal for extension of the Letter of Approval of such Units shall be considered by the Board of Approval.

(a) & (c): Districts as Export Hubs initiative covers all the districts in India. Products and services with export potential have been identified in all the 33 districts of Rajasthan, 30 districts of Odisha,

75 districts of Uttar Pradesh and 13 districts of Andhra Pradesh under this initiative. A list of products/services as identified by the respective districts in Rajasthan, Odisha, Uttar Pradesh and Andhra Pradesh is at *Annexure I*. The list is regularly updated on the basis of inputs received from various stakeholders including States and UTs.

(b)& (d): The export data of top 5 items under Principal Commodity Groups, from the districts of Rajasthan, Uttar Pradesh, Odisha and Andhra Pradesh during Financial Year 2021-22 (upto December, 2021) is at *Annexure II* 

(e)& (f): Kondapalli toys, Etikoappa toys, Mehendi, Amla products and Pulses have been identified as products with export potential under the Districts as Export Hubs initiative in Krishna district (Andhra Pradesh), Vishakhapatnam district (Andhra Pradesh), Pali district (Rajasthan), Pratapgarh district (Uttar Pradesh), Gonda district (Uttar Pradesh) respectively. Products and services from all the districts in the country have been identified on the basis of inputs provided by the relevant stakeholders including State/UTs and regional authorities of DGFT. Efforts to promote export of these products from the districts through a combination of capacity building, product development and market development through convergence of schemes is an ongoing exercise.

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (f) OF LOK SABHA STARRED QUESTION NO. 14 FOR ANSWER ON 02<sup>nd</sup> FEBRUARY, 2022 REGARDING "PROMOTION OF TURMERIC".

a) The mandate for production, research, development, domestic marketing of Spices including Turmeric is vested with Union Ministry of Agriculture & Farmers welfare. However, Spices Board as per its mandate for production and research of Cardamom and post-harvest management, quality control and export promotion of 52 Spices, has been undertaking activities for post-harvest improvement, building market linkages, export promotion, etc. of spices including turmeric, which has benefitted the stakeholders.

The data on the quantity and value of turmeric consumed domestically is not available with the Government. However, the data on the state-wise production of Turmeric is available and attached as Annexure-I.

b) Government through Spices Board has been promoting Indian spices, including turmeric through various campaigns on its social media handles on Twitter, Meta (Facebook), YouTube, Instagram, Koo (Indian app), LinkedIn etc. These campaigns cover the culinary, medicinal and industrial applications of Indian spices besides providing authentic and scientific information on production, post-harvest processing, value addition, etc. The campaigns on spices are run on social media so as to transcend borders and appeal to spice enthusiasts all over the world. Social media posts are updated on a daily basis with interactive content.

In addition to routine social media updates, the Board has been organising various focus events in collaboration with various influencers and media houses for promoting the value and worthiness of Indian spices. Also, the Government, through the Spices Board, is actively conducting Virtual Buyers Sellers Meeting(VBSM) in various countries and by making use of the digital/ online medium for promoting spices and spice products, series of webinars, entrepreneurship development training programs, etc, involving various stakeholders have been organized.

c) Spices Board's scheme titled 'Integrated Scheme for Export Promotion & Quality Improvement in Spices and Research & Development of Cardamom', for implementation during the period from 2021-22 to 2025-26 has been approved. The Export Development & Promotion (EDP) component of the above said scheme aims at promotion of turmeric and other spices in the international market, supporting exporters for infrastructure development, value addition, trade promotion etc. Under the scheme, an annual outlay of Rs. 18.00 crores has been allotted to the EDP component for the period from 2021-22 to 2025-26, which will be used for activities/programs in connection with the international promotion of turmeric and other spices.

In addition to the programs under the EDP component, various programs are implemented under scheme components such as Export Oriented Production (EOP) (support for post harvest improvement, processing etc), Quality Improvement (QI) (quality management for exports, analytical services for assessing the intrinsic parameters such as curcumin in turmeric etc to the growers and other stakeholders) etc, which contributes to export promotion of turmeric from India.

Besides, Government of India, through the Ministry of Agriculture & Farmers Welfare implements several development programmes for horticulture crops, including turmeric, through State Departments under Mission for Integrated Development of Horticulture (MIDH) with an aim to improve production, productivity and quality of the produce and thus augmenting farmers' income. Major among them are the establishment of new gardens (area expansion), Integrated pest Management/Integrated Nematode Management, micro irrigation, organic farming, creation of water resources, post-harvest management, development of market yards, human resource development etc.

d) The Country-wise export quantity and value of Turmeric during 2014-15 till 2020-21 has been attached in Annexure-II.

e) No such proposals have been received by the Department of Commerce.

- (c) whether the Government has introduced the Polluter Pays Principle in the text of the negotiations at WTO for the fisheries sector; if so, the details thereof; and
- (d) the steps taken by the Government to safeguard the interest of the domestic fisheries sector against the heavily subsidized high sea fishing by developed countries?

# THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

(a) to (d): As per mandate of the United Nations Sustainable Development Goal (UNSDG) Target 14.6, Members are negotiating discipline on fisheries subsidies in the World Trade Organization (WTO), with a view to adopting an agreement on comprehensive and effective disciplines that prohibit certain forms of fisheries subsidies that contribute to overcapacity and overfishing and eliminate subsidies for Illegal, Unreported & Unregulated (IUU) fishing and for fishing of overfished stocks. Inbuilt flexibilities to use conservation and management measures for continuing subsidies is also part of these disciplines.

The mandate also provides for appropriate and effective special and differential treatment for developing country Members. In this context, in these negotiations, India has sought policy space to support low income, resource-poor or livelihood fishing or fishing related activities up to our EEZ, to develop and modernize our fisheries sector and for expanding our fishing activities in the high seas.

India has also introduced a document in the WTO on 23 September, 2021, containing 'Polluter Pays' principle for fisheries subsidies negotiations, which proposes moratorium on subsidies by distant water fishing nations for fishing and fishing related activities beyond their Exclusive Economic Zone (EEZ) and also seeks reduction commitments on distant water fishing capacity by those nations. India is not a distant water fishing nation.

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (f) OF LOK SABHA STARRED QUESTION NO. 16 FOR ANSWER ON 02<sup>nd</sup> FEBRUARY, 2022 REGARDING "BOOSTING OF SERVICES EXPORTS".

- (a) The initiative taken by the Government of India for promoting IT/ ITeS industry in the country are as below:
  - i. National Policy on Software Products-2019 with an aim to develop India as the global software product hub, driven by innovation, improved commercialization, sustainable Intellectual property (IP), promoting technology start-ups and specialised skill sets, for development of the sector, based on ICT has been approved. The objective of the policy is to create a robust Indian Software Product development ecosystem leading to ten-fold increase in India share of the Global Software product market and so as to generate direct and in-direct employment for 3.5 million people by 2025.
  - ii. Next Generation Incubation Scheme (NGIS) has been approved to support software product ecosystem and to address a significant portion of National Policy on Software Product (NPSP 2019). It is envisaged to create a vibrant software product ecosystem to complement the robust IT Industry for continued growth, new employment and enhance competitiveness.
  - Some other initiatives to promote IT sector exports include Future Skills PRIME, Market Development Initiative in Nordics and Africa Region, Market Outreach Initiatives etc. under Champion Sector Services Scheme.
  - iv. Further, in order to promote trade in services including IT services, Department of Commerce follows a multi-pronged strategy which comprises seeking meaningful market access through multilateral, regional and bilateral trade agreements. Focused efforts are also being made to address mobility issues being faced by the service suppliers and resolve barriers if any, faced by the exporters and other stakeholders as a part of these agreements.
- (b) A target of US\$ 400 billion for Merchandise exports for FY 2021-22 has been set. These targets have been communicated to State Governments, Missions Abroad and all Export Promotion Council (EPCs) for action. Following are some of the steps taken to increase exports:
  - i. 'Districts as Export Hubs'(DEH) Initiative under which products and services with export potential have been identified in all districts of the country. An institutional mechanism has been set up in each District in the form of District Export Promotion Committees (DEPCs). The primary function of the DEPC is to prepare and act on District Specific Export Action Plans in collaboration with all the relevant stakeholders from the Centre, State and District levels.

- A Central Sector Scheme 'Transport and Marketing Assistance (TMA) for Specified Agriculture Products' for providing assistance for the international component of freight, to mitigate the freight disadvantage for the export of agriculture products, and marketing of agricultural products, is under implementation.
- iii. Market Access Initiative (MAI) Scheme is an Export Promotion Scheme envisaged to act as a catalyst to promote India's exports on a sustained basis. The scheme is formulated on focus product-focus country approach to evolve specific market and specific product through market studies/survey. Assistance would be provided to Export Promotion Organizations/Trade Promotion Organizations/National Level Institutions/ Research Institutions/Universities/Laboratories, Exporters etc., for enhancement of exports through accessing new markets or through increasing the share in the existing markets.
- iv. In addition, assistance to the exporters of agricultural products is also available under the Export Promotion Schemes of Agricultural & Processed Food Products Export Development Authority (APEDA), Marine Products Export Development Authority (MPEDA), Tobacco Board, Tea Board, Coffee Board, Rubber Board and Spices Board.
- v. Trade Infrastructure for Export Scheme (TIES) is operational from FY 2017-18 with the objective of assisting Central and State Government agencies for creation of appropriate infrastructure for growth of exports.
- vi. The Government has introduced the Remission of Duties and Taxes on Exported Products (RoDTEP). This scheme seeks remission of Central, State and Local duties/taxes/levies at different stages at the Central, State and local level, which are incurred in the process of manufacture and distribution of exported products, but are currently not being refunded under any other duty remission scheme.
- vii. Common Digital Platform for Certificate of Origin to facilitate trade and increase FTA utilization by exporters.
- viii. EPCs, Commodity Boards and India's mission abroad are actively promoting India's trade, tourism, technology and investment goals.
- (c) Software Technology Parks of India (STPI), an autonomous society under Ministry of Electronics and Information Technology has established 62 STPI centres across the country, of which 54 centres are located in Tier II and Tier III cities. To create employment opportunities and dispersal of IT/ITES industry in small cities and towns (excluding metro locations), Government had launched two BPO promotion schemes, namely India BPO Promotion Scheme (IBPS) and North East BPO Promotion Scheme (NEBPS). These schemes aim to incentivize setting up of 53,300 seats BPO/ITES operations by providing financial support up to 1 lakh per seat in the form of viability gap funding. Since the inception of these schemes, around 250 units have set up BPO/ITES operations across 27 States/UTs of the country, providing direct employment to over 47,000 persons. Under these schemes, the disbursements of financial support are on reimbursement basis directly linked with the objective i.e. employment generation by the units.

- (d) The STPI centres are being set-up by STPI from its own internal accruals as per the extant policy of setting-up of new STPI centres, no funds are being sanctioned or released by the Union Government for this purpose. Till now, financial support of Rs. 80 crores have been disbursed to BPO/ITES units under IPBS and NEBPS schemes.
- (e) The State-wise list of existing STPI Centres is at Annexure-I.
- (f) In order to create favourable ecosystem for start-ups, various domain-centric Center of Excellences (CoEs) have been set-up by Ministry of Electronics and Information Technology (MeitY) in collaboration with suitable partners and stakeholders (State Government, Industry/ Industry Associations, Academia) in various parts of country. These CoEs are acting as single-window facilitators to extend requisite lab support, funding, mentoring services, etc. Further, to help IT industry to grow rapidly and contribute to country's exports of services; Software Technology Park (STP) Scheme a 100% export-oriented scheme is being implemented by STPI for the development and export of computer software using communication links or physical media and including export of professional services.

- Technology Incubation and Development of Entrepreneurs (TIDE 2.0) Scheme
- MeitY Start-up Hub (MSH)
- Scheme for Accelerating Startups around Post COVID Technology Opportunities (SASACT)
- Start-up Accelerator Programmes
- Electronic system and design manufacturing Entrepreneur Parks
- Support for International Patent Protection in E&IT (SIP-EIT) Scheme for SMEs

(a) to (c): Yes, Coffee Board is implementing the Integrated Coffee Development Project (ICDP) under which various interventions such as research & development, technology

transfer, capacity building, support to mechanisation of estates, coffee area development, market development, support to value addition etc. for overall improvement of production, productivity and quality of coffee. During the last three years i.e. 2018-19 to 2020-21 and current year upto December 2021, Coffee Board has provided financial assistance amounting to Rs. 159.86 crores towards various components of the scheme.

(d) The Government has accorded due priority to the promotion and development of organic coffee production in the country. The Coffee Board is providing technical support and guidelines for organic coffee cultivation in all coffee growing states, with special reference to Tribal growers. Under the "Integrated Coffee Development Project" the Coffee Board has, inter alia, implemented Eco-Certification / Organic Certification programme to encourage production of eco-certified coffees by adhering to quality standards.State-wise production data of organic coffee as per APEDA is as under:

- (e) &(f): Coffee plantations especially in the state of Karnataka and Kerala have suffered losses due to natural calamities, drought and unseasonal rains. Compensation to eligible growers is disbursed from the Office of District Administration to eligible growers as per NDRF/SDRF norms.
- (g) : As per the assessment made by the Coffee Board, while harvesting of crop was not much affected, some estate operations were delayed due to covid lockdown, which may have had an impact on the coffee crop. Due to restrictions imposed to contain the spread of pandemic, demand from hotels, restaurants, café business as well as offices, vending machines, events etc., which are the major out-of home customers, were impacted. With regard to exports, there were disruptions in the logistics, postponement of shipment orders, paucity of containers, high fright rates etc. which affected coffee exports during the first phase of lockdown. Coffee trade has picked up after relaxation in the restrictions and the coffee exports have increased by 45% in value terms (USD) during April to December 2021 as compared to same period during 2020.

Corrective measures taken by the Coffee Board to facilitate coffee exports are as under:

- i. Coffee Board has implemented online issuance of export documents with digital signature viz., RCMC, export permit and ICO Certificate of Origin. Export permits and ICO certificate of origin are issued instantly on the same day of receipt of online applications.
- ii. Further, Coffee Board increased periodicity of renewal of RCMC certificate from 3 years to 5 years and the validity period of export permits (Form C) and ICO certificate of origin have been extended from 30 days to 60 days.
- iii. Besides, the Coffee Board integrated Licenses/ Permits/ Certificates/ Other Authorizations (LPCOs) on ICEGATE e-Sanchit portal for quick customs clearance.
- iv. Due to COVID induced restrictions, virtual Buyer-Seller interactions were organised in the major markets / prospective countries (Italy, Netherlands, France, Portugal, Egypt, Singapore etc.)
- v. Online interactions between different stakeholders are being organised to give boost to the trade.

(i) Production Linked Incentive Scheme for promotion of domestic manufacturing of critical Key Starting Materials (KSMs)/ Drug Intermediates (DIs)/ Active Pharmaceutical Ingredients (APIs) in India.

- The Union Cabinet approved the scheme on 20.03.2020 with the objective to boost domestic manufacturing of identified KSMs, DIs and APIs.The tenure of the scheme is from FY 2020-21 to 2029-30, with the total financial outlay of Rs. 6,940 crores.
- The Financial incentive under the sub-scheme is provided on sales of 41 identified products categorized into four Target Segments.

## (ii) PLI Scheme for Pharmaceuticals: -

- Eligible drugs under this scheme approved on 24.02.2021 include Active Pharmaceutical Ingredients among other categories of pharmaceutical products. The Operational Guidelines have been issued on 1.6.2021.
- The total financial outlay of the scheme is Rs. 15,000 crore and the tenure of the scheme is from FY 2020-2021 to 2028-29.

## (iii) Scheme for Promotion of Bulk drug parks

- The scheme of "Promotion of Bulk Drug Parks" approved on 20th March, 2020. The scheme provides for support to establish three (03) Bulk Drug Parks for creation of world class Common Infrastructure Facilities (CIF). Guidelines of the scheme were notified on 27<sup>th</sup> July 2020.
- The total financial outlay of the scheme is Rs. 3000 crores. The tenure of the scheme is from FY 2020-2021 to FY 2024-2025.

(a): Yes, Sir. India's agricultural exports have increased from USD 39.19 billion in 2018-19 to USD 41.87 billion in 2020-21.

(b): Details of India's export of rice, during the years 2015 -16 to 2020-21, are at Annexure.

(c) : Biggest importing countries for Basmati rice are Saudi Arabia, Iran, Iraq, Yemen and UAE; whereas the biggest importing countries for non-basmati rice are Benin, Nepal, Bangladesh, Senegal and Togo.

(d): As per WTO rules, there are no limits prescribed for agricultural exports.

(e) & (f) : Does not arise in view of (d) above.

(g): Promotion of exports of agricultural products is an ongoing process. To promote agricultural exports, the Government has taken several steps at State/ District levels. State specific Action Plans, State Level Monitoring Committees (SLMCs), Nodal Agencies for agricultural exports and Cluster Level Committees have been formed in a number of States. Country and product-specific action plans have also been formulated to promote exports.

A Farmer Connect Portal has been set up by APEDA for providing a platform for farmers, Farmer-Producer Organizations (FPOs) and cooperatives to interact with exporters. Buyer-seller Meets (BSMs) have been organized in the clusters to provide export-market linkages. Regular interactions, through videoconferences, have been held with the Indian Missions abroad, to assess and exploit export opportunities. Country specific BSMs, through Indian Missions, have also been organized.

The Government has also introduced a Central Sector Scheme – 'Transport and Marketing Assistance for Specified Agriculture Products' – for providing assistance for the international component of freight, to mitigate the freight disadvantage for the export of agriculture products.

The Department of Commerce provides assistance through several other schemes, to promote exports, including exports of agricultural products viz. Trade Infrastructure for Export Scheme (TIES), Market Access Initiatives (MAI) Scheme, Merchandise Exports from India Scheme (MEIS) etc. In addition, assistance to the exporters of agricultural products is also available under the Export Promotion Schemes of Agricultural & Processed Food Products Export Development Authority (APEDA), Marine Products Export Development Authority (MPEDA), Tobacco Board, Tea Board, Coffee Board, Rubber Board and Spices Board.

(c) : The financial assistance of Rs.18,000/Ha. is extended by the District Administration under NDRF/SDRF, where the crop loss is 33% and above subject to a ceiling of 2Ha. per farmer. In addition, Coffee Board through its scheme "Integrated Coffee Development Project" has provided financial assistance amounting to Rs.159.86 crores during the last three years i.e. 2018-19 to 2020-21 (up to December 2021) under various interventions such as technology transfer, capacity building, support to mechanization of estates, coffee area development, market development, support to

value addition and research & development etc. for overall improvement of

production, productivity and quality of coffee.

(d) &(e): Guidelines issued by RBI on 17.10.2018 provides for restructuring of loans due to natural calamities. Further, Interest Subvention Scheme is already being implemented by Department of Agriculture & Farmers Welfare which covers short term loans upto 3 lakhs at effective rate of 4% per annum for coffee plantation sector. At present, no proposal for loan waiver or special package for coffee plantation sector is under consideration.

- (a) Department of Commerce has not received any representation or information regarding plight of cashew processors of Andhra Pradesh for export of Palasa Cashew in international market, till date.
- (b) & (c) Promotion of exports of agricultural products is an ongoing process. To promote agricultural exports including cashew, the Government has introduced a Central Sector Scheme 'Transport and Marketing Assistance for Specified Agriculture Products' for providing assistance for the international component of freight, to mitigate the freight disadvantage for the export of agriculture products. The Government has also taken several steps at State/ District levels. State specific Action Plans, State Level Monitoring Committees (SLMCs), Nodal Agencies for agricultural exports and Cluster Level Committees have been formed in a number of States. Country and product-specific action plans have also been formulated to promote exports. A Farmer Connect Portal has been

set up by APEDA for providing a platform for farmers, Farmer-Producer Organizations (FPOs) and cooperatives to interact with exporters. Buyer-seller Meets (BSMs) have been organized in the clusters to provide export-market linkages. Regular interactions, through videoconferences, have been held with the Indian Missions abroad, to assess and exploit export opportunities. Country specific BSMs, through Indian Missions, have also been organized. Besides these steps taken by the Government, the Department of Commerce also provides assistance through several other schemes, to promote exports, including exports of agricultural products viz. Trade Infrastructure for Export Scheme (TIES), Market Access Initiatives (MAI) Scheme, Merchandise Exports from India Scheme (MEIS) etc. In addition, assistance to the exporters of agricultural products is also available under the Export Promotion Schemes of Agricultural & Processed Food Products Export Development Authority (APEDA).

(a): Domestic Natural Rubber (NR) prices have increased in the country in the recent past. The average price of RSS4 grade sheet rubber for the period of April to December 2021 was Rs. 172.82 per kg compared to the yearly average of Rs. 141.85 per kg during 2020-21.

As domestic Natural Rubber is highly sensitive and is linked to prevailing international prices of natural rubber, the Government has been taking steps from time to time to ensure that domestic farmers get remunerative prices for their produce.

(b): No such proposal is under consideration of the Government.

(c) & (d): The task force on rubber sector has recommended treating Natural rubber (NR) as an agricultural product and its inclusion under Minimum Support Scheme (MSP). The Government of India fixes MSP for 25 agricultural crops. These prices are fixed on the basis of recommendations of the Commission for Agricultural Costs & Prices (CACP). Natural Rubber is not included in the selected 25 crops for which Minimum Support Price (MSP) is notified, as it does not fulfill most of the criteria for inclusion under MSP, and is not covered under the Comprehensive Scheme for studying the cost of cultivation of principal crops in India.

(b) and (c): As seen from the table above, the exports to China have increased from USD 17.33 billion in Jan-Nov 2020 to USD 21.54 bn in Jan-Nov 2021 exhibiting an increase of 24%. The imports have increased from USD 52.16 bn in Jan-Nov 2020 to USD 78.88 bn in Jan-Nov 2021. However, the imports were static between 2019-20 and 2020-21.

The major items of import from China are products such as telecom instruments, computer hardware and peripherals, fertilizers, electronic components/ instruments, project goods, organic chemicals, drug intermediates, consumer electronics, electrical machinery etc. Some of our imports from China like the Active Pharmaceutical Ingredients (APIs) and drug formulations provide the Indian pharma industry raw material for producing finished goods which are also exported out of India.

(d): The details of value and volume of the five major imports and exports to China during the years 2020 (Jan-Nov) and 2021 (Jan-Nov) is given in Annexure-I.

(a) to (c): Yes, Sir. The National Centre for Organic Farming (NCOF), under the Ministry of Agriculture & Farmers Welfare is the nodal organization for organic farming in the country. NCOF implements the National Project on Organic Farming (NPOF) to promote production, certification and marketing of organic products. The National Programme for Organic Production (NPOP), introduced by the Department of Commerce, is aimed at regulation and promotion of organic production for exports.

The promotion of exports of organic products is a continuous process. The Agricultural & Processed Food Products Export Development Authority (APEDA), an autonomous organisation under the administrative control of Department of Commerce, has been mandated with implementation of NPOP and export promotion of organic products. APEDA provides assistance to the exporters of organic products under various components of its export promotion scheme. APEDA also undertakes various activities to promote exports of organic products viz. addition of new products under NPOP, making

efforts to get NPOP standards recognized by the importing countries, promoting 'India Organic' brand through participation in international trade fairs and exhibitions, organising Buyer-Seller Meets (BSMs), organising capacity building and outreach programmes etc.

India's exports of organic products amounted to USD 1.04 billion during 2020-21. Organic foodgrains are being exported from the country mainly under the category Cereal & Millets. During 2020-21, 59908 MT of organic products under the category 'Cereal & Millets', worth 76 million USD, have been exported from India under the National Programme for Organic Production (NPOP).

Government of India has been promoting Organic farming in the country, including in Bundelkhand and Uttarakhand, through dedicated schemes namely Paramparagat Krishi Vikas Yojana (PKVY) and Mission Organic Value Chain Development for North Eastern Region (MOVCDNER) since 2015-16 to cater to the needs of domestic and export markets respectively. Marketing and branding have been integral part of organic farming schemes. Assistance of Rs 6800/ ha under PKVY and Rs 5000/ ha under MOVCDNER is provided for marketing, branding and trade. Brand 'Organic Uttarakhand' has been developed under PKVY for the State of Uttarakhand.

- (a) whether is it true that United States has approved import of mangoes and pomegranates from India in exchange of supply of cherries, alfalfa hay, pork and pork products to India in pursuant to the 12th India-US Tade Policy Forum meeting held in November, 2021 for implementing the "2 Vs 2" Agri market access;
- (b) if so, the details thereof including the advantages and adverse effects in the Indian economy by implementing the above trade agreements; and
- (c) the terms and conditions of export and import in the above trade agreements?

# THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

(a), (b) and (c): During the 12<sup>th</sup> India – U.S. Trade Policy Forum (TPF) meeting held in November, 2021, both the countries agreed to finalize work on market access facilitation for mangoes, pomegranates and pomegranate arils from India and cherries and alfalfa hay from the United States. In addition, U.S. agreed to work to complete market access for table grapes from India to the United States, and India agreed to work to finalize the export certificate to allow the importation of pork and pork products from USA.

In pursuance of the above, the Department of Agriculture and Farmers Welfare and U.S. Department of Agriculture have signed a framework agreement for implementing the market access issues i.e., inspection / oversight transfer for Indian mangoes and pomegranates and market access for pomegranate arils from India, and market access for cherries and alfalfa hay from USA. Further, as agreed in the TPF meeting, both sides are in the process of finalizing the Veterinary Health Certificate for export of pork and pork products from USA. Similarly, the U.S. is also working on providing market access for table grapes from India.

These measures are likely to boost bilateral trade between India and the U.S., benefiting both the countries.

(a) & (b) : There has been widespread changes in the overall market scenario with reference to the development of Rubber and allied sector in the country. Therefore, to remove certain archaic provisions, create a conducive environment for ease of doing business and making a world class Rubber Industry, the Government is encouraging the replacement of the existing Rubber Act 1947 with a new legislation. In this regard, a draft Bill ' Rubber (Promotion and Development) Bill 2022' has been hosted in the official website of this Department and Rubber Board for wider consultation and seeking comments/ suggestions from public/ stakeholders.

(c) & (d): No Sir. 'Rubber (Promotion and Development) Bill' has enabling provisions with regard to realigning the provisions in the changed market scenario and to mitigate the challenges faced by the sector.

(e) & (f): No such proposal is under consideration of the Government.
